1. Call to Order.

Supervisor Ken DeWeerdts call the meeting to order. Chuck Schaap opened with prayer and led in the Pledge of Allegiance.

2. Roll Call.

Members Present: Ken DeWeerdts, Elaine Mokma, Bob Yonker, Leah Folkert and Chuck Schaap.

Members Absent: None

3. Late Agenda Items.

a. None.

4. Graafschap Fire Department.

Fire Chief Doug DenBleyker reported;

- a. A total of 77 February calls for 2023. There were 14 medical/rescue calls and 8 fire call for Fillmore Township, there were 3 fire calls and 2 medical/rescue calls to other agencies.
- b. Bob Yonker Fire Board Chairman reports receiving a letter of retirement effective April 1, 2023, from fire department member Wayne Mokma. Mr. Mokma has served the residents of Fillmore and Laketown Township for over 50 years; his knowledge and expertise will be missed. An open house celebrating his retirement will be set.

5. Fillmore/Overisel Deputy.

Officer Dillon Schmitt submitted the following report;

- a. There were 96 calls for February 2023, 69 calls for Fillmore Township and 27 for Overisel Township.

6. Allegan County Commissioner.

Jim Storey reported;

- a. 123NET filed a 30 million ROBIN grant application. This has bipartisan support. If no opposition presents in 45 days construction should begin in August 2023.
- b. Community Mental Health has moved to their new office space leaving the Allegan County Building. Board of Commissioners continue to look at all non-court functions move to the County Services Building. 3 Elected officials from Allegan County have filed a lawsuit against the Board of Commissioners over plans to move offices. Commissioner Storey presented a press release to the Board of Trustees in response to this lawsuit.
- c. Lake Allegan Dam talks continue.
- d. The Palisades Plant could possibly be repowered.
- e. Allegan County Board of Commissioners have hired Sarah Clark to assume the position of Emergency Manager.

7. Public Hearing – Fillmore Township Budget 2023 – 2024.

A Motion was brought by Chuck Schaap and 2nd by Leah Folkert to open the Public Hearing at 7:30pm. PASSED 5-0.

Supervisor DeWeerdts read the Public Notice as it recently appeared in the Holland Sentinel.

Supervisor reviewed the Budget and how funds are raised and dispersed. There being no public comment or input;
